### SPECIFIC REGULATIONS

## *My Property ID Registry* exceeds the following government regulations:

- DFARS Case 2015-D035 (April 2019): regardless of the unit cost, Federal Acquisition Regulation (FAR) clause 52.245-1, must be used in all purchase orders for repair, maintenance, overhaul, or modification of government property.
- Defense Federal Acquisition Regulation Supplement (DFARS) 252.245-7001(b): the contractor shall tag, label, or mark government-furnished property.
- Federal Acquisition Regulation FAR 52.245-1(f)(1)(ii): identify as government owned in a manner appropriate to the type of property (e.g., stamp, tag, mark, or other identification).
- NASA's NFS 1852.245–74(c)(2): use human readable, "Unique Identification Number (License Tag)," affixed to government property.
- Green Book 2 CFR Part 200.313(d)(3): use a control system to ensure adequate safeguards to prevent loss, damage, or theft of government property.
